Quality

Throughout the organisation, work is being done to improve quality. The objective is to successfully round off reviews as a test of scientific quality. Spearheads represent the motivation to ensure that clients are satisfied and that research is of a high quality.

WENR employs a quality-management system in line with the ISO standard 9001:2015, supplemented by the guidelines from ISO 31000 Risk management.

DES follows the working method in line with the ISO standard 9001:2015, supplemented by the guidelines from ISO 31000 Risk management.

WENR quality system also serves the WOT unit (statutory research tasks unit) for Nature & the Environment. The ERA team carries out its assignments in accordance with the OECD Principles of Good Laboratory Practice (GLP).

Safety, welfare and health

The management council of WENR and DES wants to offer a good quality and safe working environment and to prevent any harm to the health of employees and other concerned parties. The policy focuses on protecting personnel from pressure that could have a negative impact on their performance. Accidents and personal injury are to be prevented as far as possible. The Risk Inventory and Evaluation regarding working conditions has been implemented and approved by the Employees Council van WENR en DES in accordance with Wageningen University & Research prescribed methodology. Important spearheads include maintaining low sickness absenteeism rates and holding regular R&D interviews.

Environment

Devoting attention to the green living environment occupies a central position within the organization. The aim is to achieve continual improvement in our environmental performance. An active environmental policy forms an integral part of the organisations operations and business strategy. The organisation complies with all applicable environmental legislation and regulations, as well as Wageningen University & Research environmental policy and relevant covenants. The organisation strives for the control and reduction of the environmental impact (i.a. in the fields of waste, hazardous substances, energy and transport) and works with an environmental management system. WENR environmental management system has been certified in accordance with the NEN-EN ISO standard 14001:2015.

Corporate Social Responsibility

By applying the international guideline on Social Responsibility, NEN-EN-ISO 26000 (according to the methods described in NPR 9026:2011, the management WENR and DES wants to deal with its social responsibility (CSR) in a proper and verifiable way.
