REQUEST TO REMOVE PERSONAL DATA

Dear Executive Board of ,

With reference to the General Data Protection Regulation (GDPR), I hereby request:

If you are processing personal data of mine, that you remove my data on the basis of article 17 of the GDPR, because¹:

- These personal data are no longer required for processing by WUR or the for purposes for which they were collected
- The authorisation granted by me on _____ is being revoked and a different legal basis for the processing is applicable;
- There is opposition to the processing and there are no other justified grounds for the processing;
- The processing of my data is illegal on the basis of:
 - This goes against the statutory obligations of Wageningen University & Research;
 - The personal data being collected is in connection with the provision of services.
