**NB.** Non-NL/EEA/SME students, who pay full Institutional Tuition Fee 3 and need an extension of enrolment after their nominal study period, can receive a reduction on the tuition fee for the first 3 months of their extension. With this reduction, the tuition fee for these 3 months is equal to the Statutory Tuition Fee.

For MSc students, the discount applies in the 25th, 26th and 27th month of their registration. For BSc students the discount applies in the 37th, 38th and 39th month of their registration.

The discount is automatically processed in the invoice.

## Comments on the WU fees calculations

### **Third year MSc non-EEA students – first 3 months and fourth year BSc non-EEA students-first 3 months after having paid 24 and 36 months institutional tuition fee**

This fee is derived from the statutory fee IC1. For example € 650 is derived from the statutory fee € 2601. It is € 2601 for the whole academic year 2025-2026, so for the first three months it is 3/12 of € 2601 and that is € 633 (rounded).

### **Third year MSc non-EEA students – after first 3 months (month 4-12)**

This fee is derived from the institutional tuition fee for MSc students. For example € 15900 is derived from the statutory fee € 21200. It is € 21200 for the whole academic year 2025-2026, so for the months 4 to 12 it is 9/12 of € 21200 and that is € 15900.

### **Fourth year BSc non-EEA students – after first 3 months (month 4-12)**

This fee is derived from the institutional tuition fee for BSc students. For example € 13350 is derived from the statutory fee € 17800. It is € 17800 for the whole academic year 2025-2026, so for the months 4 to 12 it is 9/12 of € 17800 and that is € 13350.

### **Second programme – partially simultaneous for MSc and BSc non-EEA**

This group of students pay the established fee in total for the first and second programme. For example in 2025-2026 these MSc students who are following a second programme (partially) simultaneous pay € 21200 for the whole academic year. So there is no extra fee for following the second programme partially simultaneous.

### **Second programme – sequential for MSc and BSc non-EEA**

This group of students pay the established fee when they are following a second MSc programme when they started with the second programme after obtaining a degree for a MSc programme.

### **Column 21-22 adjusted**

The fees for the academic year 21-22 were set in 2020, but in 2021 the fees for the academic year 2021-2022 were adjusted. Because of the corona outbreak, it was determined by the Ministry of Education, Culture and Science (OCW) that in the academic year 2021-2022 the statutory tuition fees were reduced by 50%. WU also lowered the institutional tuition fees (ic2 and ic3) with €1.084. All fees that were derived from the (reduced) ic2 and ic3 were adjusted accordingly.
