 - a. You are a national of one of the EU countries or Iceland, Liechtenstein, Norway, Switzerland, Suriname, or
 - b. You are not a national of one of the above-mentioned countries but you belong to one of the groups as mentioned in article 2.2 of the Study Financing Act 2000 (WSF 2000)
- 2 Degree Requirement: At the start of your enrolment for a bachelor or master programme, you are not in the possession of a bachelor respectively master degree, obtained after September 1, 1991 at a Dutch Institute of Higher Education
- 3 Reduced Statutory Tuition Fee: if you start with a bachelor's programme at a Dutch Institute for Higher Education (university or hbo) for the first time in 2018-2019 and you are eligible for statutory tuition fees, you will pay half of the full statutory tuition fees in the first year of your bachelor's programme.
